

Terms and conditions for participants attending the EORTC course on CLINICAL TRIAL STATISTICS FOR NON-STATISTICIANS (STATS 2024) in Brussels

Scope

These terms & conditions apply to individually registered participants, hereafter *Participant(s)*, attending the EORTC course on **Clinical Trial Statistics for Non-Statisticians**, hereafter *STATS*, to be held in Brussels on 11-14 June 2024.

All dates or deadlines, mentioned in this and other *STATS* documents, are on Central European Time (CET).

The organiser is the EORTC, hereafter *Organiser*.

Registration

Only fully completed online registrations will be accepted. The registration will only be processed and confirmed upon receipt of full payment. The *Organiser* will e-mail a receipted bill confirming the *Participant's* registration when the *Participant's* registration fee is received on the *Organiser's* bank account. If full payment is not received by the corresponding deadline (see below) the *Participant's* request for registration will be automatically cancelled.

Deadlines for **registration and bank payment*** are:

- **10 April 2024, 23:59 CET** (early rate)
- **29 May 2024, 23:59 CET** (late rate)

(*) a copy of the bank transfer is requested by the *Organiser*

Registration includes an exclusive access to this stimulating and interactive course delivered by specialists who will help *Participants* to develop the statistical knowledge required to better understand today's cancer clinical trials.

Registration includes coffee breaks on 11-14 June 2024, a networking event on 12 June 2024, and lunches on 12-14 June 2024.

Registration does not include travel or hotel expenses.

Registrations are limited and accepted on a 'first come first served' basis.

Registration **closes on 29 May 2024, 23:59 CET**.

Methods of payment

Payments can be made either by credit card (Mastercard or Visa), or by direct bank transfer without charges to the beneficiary. The *Participant's* **name** and **registration number** must be clearly indicated in the remittance(s) to facilitate easy processing and traceability.

Cancellation & refund

Participants who need to cancel their participation are requested to inform the *Organiser* via events@eortc.org.

In case of cancellation **after 3 April 2024**, an administrative fee of 30% fee will be retained from the participation fee and deducted from any refund. Refunds will be processed after the course.

In case of cancellation **after 8 May 2024**, or if no notice of cancellation is given, no refund will be paid.

Data protection and sharing of contact details

This event is organised by EORTC, the *Organiser*.

To manage the *Participant's* registration and participation to this event, the *Organiser* collects and stores the personal information about the *Participant* in order to promote and evaluate the event and to produce statistics on participation to the events.

Your personal information may be collected through forms we ask you to complete or through the website of the *Organiser*. This can create opportunities that undertakings that have nothing to do with EORTC or *Organiser*, might use for phishing emails purposes; please be careful that you do not provide your personal data to these parties or in case of doubts, please do not hesitate to check with the *Organiser*.

Our legal basis for the processing of the *Participant's* data is contract execution (*Participant's* registration to our event), legal compliance (e.g. accountancy) and legitimate interest (statistics of participation and evaluation of the event and event promotion). *Participant's* name, specialty when relevant, organisation and country will appear on the event badges and booklets (distributed only to event *Participants*).

The processing of personal data collected falls under the EU General Data Protection Regulation 679/2016 (hereafter also "GDPR", applicable as of 25/05/2018) and the Belgian GDPR Implementation Act of 30 July 2018 regarding the protection of individuals with respect to the processing of personal data and its subsequent amendments.

Participant's data will be stored for a maximum of 10 years after the end of the event. After this period, EORTC will either anonymise or delete *Participant's* personal information.

Cancellation, Liability and Damage

The *Organiser* reserves the right to alter or cancel any *Participant* registration due to circumstances beyond its/their control, including but not limited to industrial action, postal communications, flooding, storm, lack of utilities, fire alarm evacuation, or any act of God (hereafter "Force Majeure"). If this happens, the *Organiser* will use all commercially reasonable efforts to offer the *Participant* alternative services.

The *Organiser* will refund any registration fees to the *Participants* in case of cancellation by it of the *STATS*.

In the event of postponement or cancellation of the *STATS* by the *Organiser*, the latter cannot be held liable by *Participants* for any damages, costs, or losses incurred, such as transportation and accommodation costs, financial losses and any other miscellaneous expenses directly or indirectly resulting from such postponement or cancellation.

The *Organiser* cannot be held responsible for any personal injury, loss, damage or accident to private property, or for additional expenses incurred as a result of delays or changes in air, rail, road travel or other services, or resulting from strikes, illness, weather and other similar causes, neither for any indirect damage resulting thereof.

In any event, the *Organiser* cannot be held liable for any claims resulting from, or arising out of:

- i) failure to provide any of the services contracted due to Force Majeure;
- ii) accident, injury or damage to the *Participants*, their guests, or their respective property due to their own actions, neglect or actions of others.
- iii) any indirect damage.

The *Participants* should make sure that they are fully insured against all losses or liabilities referred to in this section "Liability and Damage". The *Organiser* reserves the right to refuse any registration if the *Participant* cannot provide proof that he/she has sufficient insurance to cover his/her liability under this section.

The *Participant* shall be responsible for any damage, cost or loss caused by the act, default or negligence of the *Participant* or his/her guest(s). He/she will defend and indemnify the *Organiser* from and against any claim resulting from, or arising out of, any such damage, cost or loss and will pay on demand the amount required to remedy any such damage.
